

## Wine Shipments from the US to HK

## How much does it cost?

1. Collection from locations in and around Napa

Case Count	Minimum	1-112	113-224	225+
Napa Valley / Sonoma Valley	USD130	USD3.5	USD3.25	USD3

- This is a per carton irrespective of size or any collection from any location/winery in Napa/Sonoma to the consolidation facility in Benicia.
- There is a USD130 minimum per each pickup location. For example, supplier 1 in St. Helena only has 2 cartons for a pickup, that pickup will be rated at USD130 + Fuel. Supplier 2 has 56 cartons in Sonoma, CA, they would be charged USD3.50 per carton + Fuel since total cost would exceed USD130 minimum.
- Vehicles will be temperature controlled.
- Deliveries arranged by wine owners to the consolidation facility in Benicia will be charged USD50 per order.
- 2. Refrigerated Consolidation Service: Total all-inclusive cost per case from consolidation facility in Benicia to CWC in HK
- USD25 per case (9-Liter Equivalent)
- USD15 per case (6-bottle / 4.5-Liter Equivalent or single bottle cases irrespective of bottle format)
- 3. Comprehensive Insurance:
- Insurance coverage is compulsory and is charged at 0.5% of the declared value.
- There is no deductible charged in the event of loss.
- The replacement value is based upon the declared value of the wine.

It would be appreciated if you would send me your expression of interest, number of cases, and US contact person (copied to Ms Vicki Chik), so that we may begin to arrange this shipment for you.

## What Should You Do? Step By Step Instructions

Follow these simple directions, after-which CWC staff will take care of everything on your behalf up to and including the wine's arrival and registration at our HK Cellars.

- 1. Contact your US storage company or wine supplier via e-mail stating your intention to relocate your wine to HK.
- 2. Provide them with a list of which wines you would like to remove.
- 3. Instruct them to deliver your wines to Hildebrand, 5341 Industrial Way, Benicia, CA 94510 (our appointed agent in the US). Or alternatively request that we arrange collection for you.
- 4. Request that they issue sales invoice (if applicable) or a valuation invoice dated within the past 12 months, providing all details of the wine for insurance and import purposes.
- Commercial invoice is needed for supplier reference and our records
- The cases to be collected or delivered must be palletized by the supplier
- All deliveries must be clearly marked: Crown Wine Cellars Shipment to Hong Kong
- 5. What information do you need to give to CWC
- Physical collection address, contact person and contact details
- Number of cases, and case sizes (i.e. 12 bottle, 6 bottle etc)
- Commercial invoice is needed for supplier reference and our records
- The cases to be collected must be palletized by the supplier
